- 2. I am over the age of eighteen, competent to testify, and have personal knowledge of the information contained within this affidavit.
- 3. Robert Ingersoll has been one of my customers for approximately nine years, during which time I designed and created floral arrangements for him for many different occasions.
- 4. I have enjoyed a warm and friendly relationship with Robert, knowing that he identified as gay and was in a relationship with Curt Freed.
- 5. The fact that Robert identifies as gay and was in a same-sex relationship never lessened his dignity or worth in my eyes, or the respect I gave to him as a longtime customer and friend.
- 6. In March 2012, Robert came to my shop to see if I would design the flowers for his wedding to Curt.
- 7. I had designed and created flowers for Robert and Curt in the past, but I believe that doing the flowers for any same-sex wedding would give the impression that I endorsed same-sex marriage.
- 8. My deeply held religious belief is that God defines marriage as a spiritual union between one man and one woman.
- 9. As a matter of faith, I cannot go against God's definition of marriage or assist other's in doing so.
- 10. I believe that participation in same-sex ceremonies and using my artistic talent to design and create the floral arrangements that are an important component of weddings would go against God's definition of marriage.
- 11. Agreeing to do flowers for any marriage ceremony not between one man and one woman would violate my conscience and my deeply held religious beliefs.
