21 Plan. YVLLC has conferred with Plaintiffs regarding this Motion. Plaintiffs do not  
22 object to the Motion. YVLLC has not conferred with Defendants regarding this Motion.

1 YVLLC is a group of local Latina/o Leaders who advocate for just political  
2 representation. Those in the group have worked for many years to make Yakima and the  
3 Yakima Valley a better place for all its residents, but most especially a better place for  
4 Latino residents to live, work, and raise families. Many have business owners and long-  
5 time community members, and many have run for office and supported other Latino  
6 candidates in Yakima.
