17	I, Yaroslav Trusevich, am over the age of 18 years of age, competent to testify to the		
18	matters below, and declare based upon personal knowledge:		
19	1. I am an Informational Technology Specialist 4 at Eastern State Hospital. By		
20	way of background, I received a Bachelor of Science degree in Physics and a Master's in		
21	Social Work from Eastern Washington University.		
22	2. In my position as an Informational Technology Specialist 4, I develop and		
23	implement processes for monitoring and measuring outcomes of activities and compliance with		
24	legal obligations related to the Forensic Servic	es Unit. In doing so, I gather information and	
25	prepare data summaries and narrative reports.

- 3. I track referrals from state courts to Eastern State Hospital for competency evaluation or competency restoration of criminal defendants. Specifically, I compile data once a week of the numbers of defendants on the waiting lists for inpatient felony evaluation, inpatient misdemeanor evaluation, inpatient felony restoration, inpatient misdemeanor restoration, and out of hospital felony and misdemeanor evaluations.
- 4. In support of my data compilations, I include a weekly spreadsheet of the individual defendants on the waiting list for admission to Eastern State Hospital for competency evaluation or competency restoration with their names redacted. This spreadsheet includes the date of the court order, the date of the competed referral, the reason for the referral, and how many days the defendant has been on the waiting list for admission.
- 5. Attached as Attachment A is a copy of the Inpatient Waiting List for Monday, November 24, 2014. The data I compiled for this document indicates that on that date, some defendants had waited up to 20 days in jail for 45-day competency restoration from the date that the court order was received, up to 5 days for 90-day competency restoration, and up to 47 days for in-patient felony competency evaluation. There were no individuals waiting for times for admission for misdemeanor competency evaluation or misdemeanor restoration. This document is a true and accurate copy of the original, except that the names of the defendants have been redacted.
- 6. Attached as Attachment B is a copy of the Off Site Waiting List for out of hospital evaluations for Monday, November 24, 2014. The data I compiled for this document indicates that on that date, a defendant had waited up to 59 days in jail for a felony competency evaluation (while Attachment B indicates that the 4<sup>th</sup> defendant on the list waited 68 days in jail after ESH received the court order, the police report didn't arrive for 9 more days). Attachment B also indicates that on that date, a defendant had waited up to 31 days in jail for a misdemeanor competency evaluation (while Attachment B indicates that the 6<sup>th</sup> defendant on

1	the list waited 63 days in jail after ESH received the court order, the police report didn't arrive
2	for 32 more days). This document is a true and accurate copy of the original, except that the
3	names of the defendants have been redacted.
