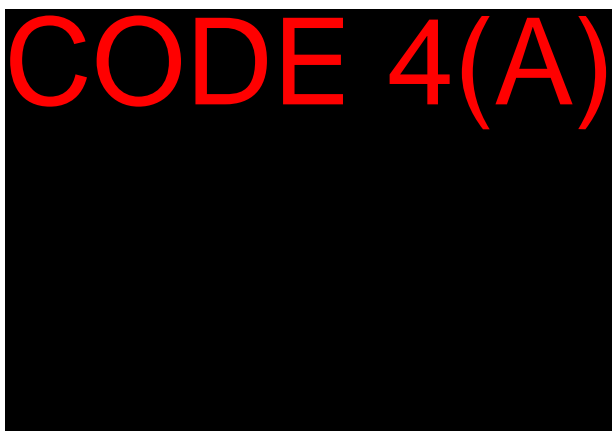

Also, when I add or delete a name, I add/delete to both BAT and FIT lists. If you prefer to be added/deleted to only one of the lists, specify that in your request.
