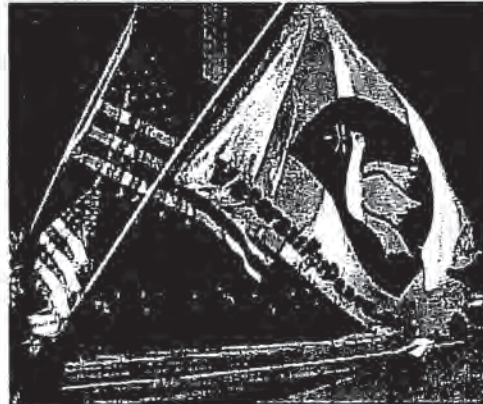
Statement of Purpose

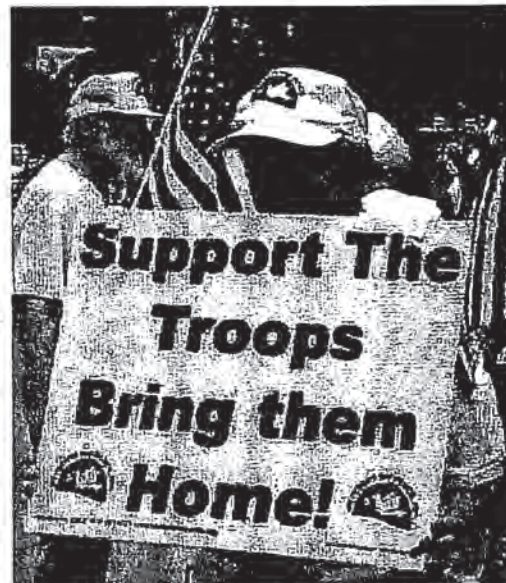

Auburn, Washington is designated by the Veterans Day National Committee and the US Department of Veterans Affairs as a Regional Site for celebration of Veterans Day 2012. Auburn has hosted the Veterans Day Parade since 1965. Now in its 47th year, the parade has grown into one of the largest Veteran's Day parades in the United States of America. Auburn's 2012 parade is paying special tribute to the American Veterans (AMVETS).

The purpose of Auburn's Veterans Day Parade is to positively focus on honoring our country's veterans and active military personnel. Through our parade, we focus recognition on congressionally-recognized Veteran Service Organizations and their auxiliaries, the military and reserve military, National Guard and ROTC. The goals and purposes of Auburn's Veterans Day Parade are to give honor to our country's military personnel and veterans and to their military missions of defending freedom around the world.

The 47th annual Veterans Day Parade will be held in Auburn on Saturday, November 10 at 11:00 AM The parade boasts almost 200 units and over 5,500 parade participants, including over 25 marching bands, military vehicles, veterans' units, honor guards and more.



The one-mile parade route travels west along Main Street to A Street NW. To participate in Auburn's Veterans Day Parade. The parade has more applicants than it can permit to participate, and thus must select among the applicants those who will be able to participate. Those applications who are approved will be those that most closely meet the goals and purpose of Auburn's Veterans Day Parade.

EXHIBIT C

PARADE RULES & REGULATIONS

The purpose of Auburn's Veterans Day Parade is to positively focus on honoring our country's veterans and active military personnel. Through our parade, we focus recognition on congressionally-recognized Veteran Service Organizations and their auxiliaries, the military and reserve military, National Guard and ROTC. The goals and purposes of Auburn's Veterans Day Parade are to give honor to our country's military personnel and veterans and to their military missions of defending freedom around the world. The Parade has more applicants than it can permit to participate, and thus must select among the applicants those who will be able to participate. Those applications who are approved will be those that most closely meet the goals and purpose of Auburn's Veterans Day Parade.

1. Parade applications must be received by Friday, October 5, 2012. Late applications will not be accepted.
2. All entries must be approved before entering the line of march.
3. Veterans Day Parade protocol is as follows for marching order: active military leads the parade, the state commander from each veterans service organization is followed by their veteran service organization's representatives, followed by other veteran groups, invited political dignitaries and community groups.
4. Parade participation is limited to military entries, veteran service organization entries, veteran groups, invited dignitaries, Auburn service clubs, Auburn scouting groups, high school bands, drill teams, municipal entries, car clubs and other invited groups. If your group/organization does not fit this criteria, please consider participating in the Curb Competition – another great way to honor our veterans!
5. No entries may invite other units/participants to join their approved entry into the parade unless approved in advance by the City of Auburn.
6. Parade participation is not open to commercial entries. Approved entries may not display commercial material of any kind.
7. Campaigning is strictly prohibited.
8. Parade participation is not open to entries comprised of one individual, unless invited by the City of Auburn.
9. Auburn scouting groups will march as one combined group (e.g. Auburn Boy Scouts, Auburn Girl Scouts, Campfire, etc.)
10. No materials (gifts, candy, merchandise, literature, bubbles or other) may be handed out or thrown from participants in the parade. This policy will be strictly enforced by the Seafair Parade Marshals, who will be serving as the parade marshals for Auburn's Veterans Day Parade.
11. Any maneuvering, countermarching or other action delaying the forward progress of the parade beyond a reasonable time is prohibited.
12. Animal units must provide their own waste removal system.
13. The American flag must be displayed in an appropriate manner.
14. Entries are required to check-in with the Seafair Parade Marshals between 9:30am – 10:30am. Latecomers are placed in parade at random or may be held out of the parade. Approved entries will be mailed complete event information in late October. Line-up information is posted online at www.auburnwa.gov.
15. Parade floats must meet code compliance. Call 253-931-3060 for additional information.
16. Merchandise vendors are not permitted on parade route.
17. All food vendors must complete the Veterans Day food vendor application form. Call 253-931-3043 for more information. Food vendors will be assigned a location within the Static Display area. Roving food vendors are not permitted.
18. All non-profit fundraisers need a permit for day-of fundraising. Call 253-931-3020.
19. The City of Auburn reserves the right to cancel any accepted entry at any time should it be determined that the entry detracts from the goals and purposes of Auburn's Veterans Day Parade.
20. The City of Auburn or the Seattle Seafair Parade Marshals reserve the right to bar or remove from the parade any entry who refuses to follow the parade rules and/or the instruction and direction from the Parade Marshals or Auburn Police.

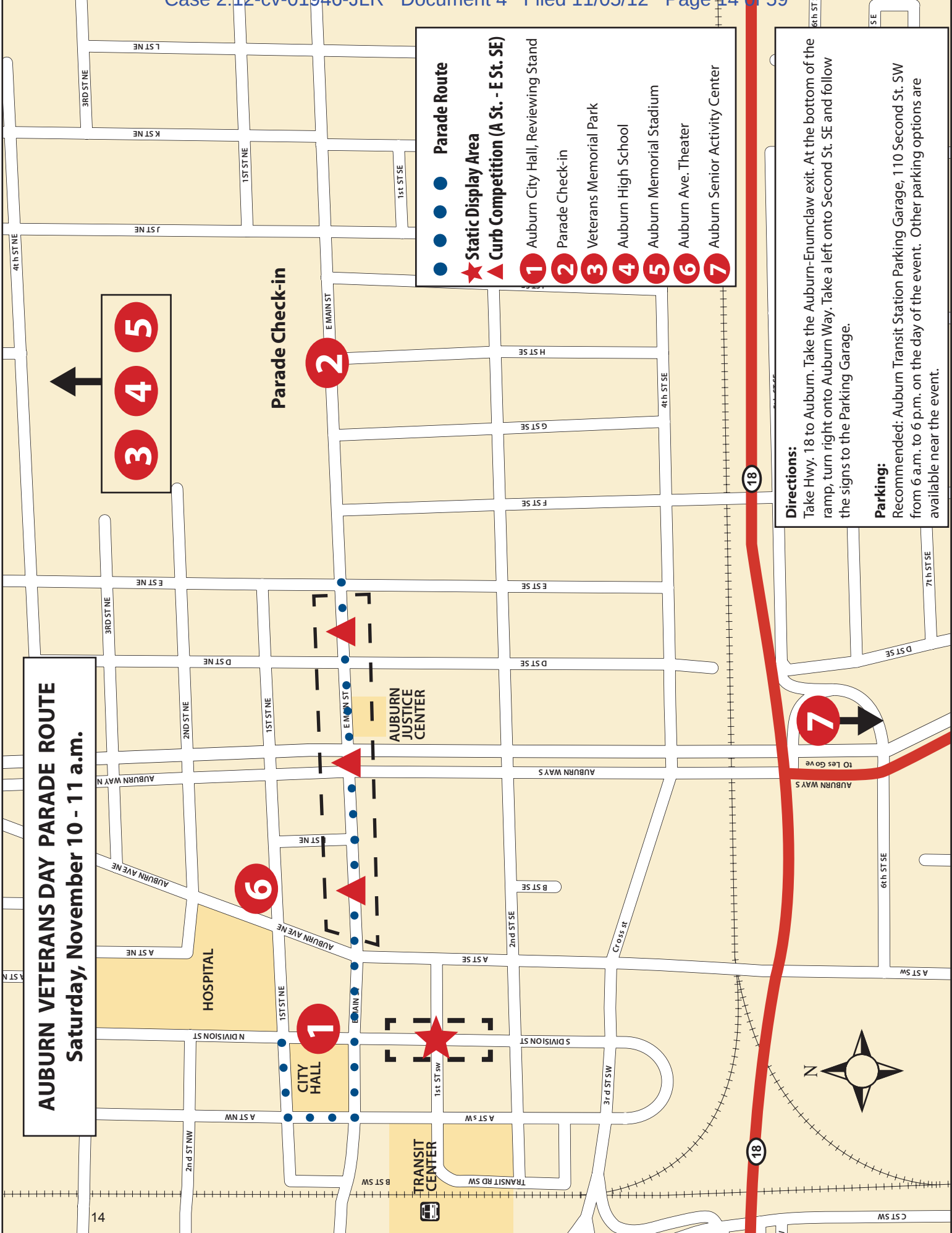

Veterans need not be DAV members to take advantage of this outstanding assistance, which is provided free of charge.

NSOs function as attorneys-in-fact, assisting veterans and their families in filing claims for VA disability compensation and pension; vocational rehabilitation and employment; education; home loan guaranty; life insurance; death benefits; health care and much more. They provide free services, such as information seminars, counseling and community outreach. NSOs also represent veterans and active duty military personnel before Discharge Review Boards, Boards for Correction of Military Records, Physical Evaluation Boards and other official panels.

For nearly a century, it has been the DAV's mission to ensure that disabled veterans receive all benefits they have earned and that the American people understand and respect the needs these veterans encounter as a result of their disabilities. It is a mission that the members of this great organization strive to fulfill every day.

The concept of serving those who have served our country has long been part of our Nation's consciousness. Recognition of that responsibility follows the standard enacted by the Pilgrims at Plymouth in 1636 which provided that any soldier who should return maimed from the defense of the settlers should be maintained by the colony for the rest of his life. President Lincoln reaffirmed this moral obligation to "care for him who shall have borne the battle and for his widow and his orphan."

In 1930, President Herbert Hoover signed Executive Order 5398 which consolidated the U.S. Veterans' Bureau, the National Homes for Disabled Soldiers and the Bureau of Pensions into the new Veterans Administration (VA). In 1989, the VA was elevated to a Cabinet-level agency and became the Department of Veterans Affairs.

Over the years, much beneficial veterans' legislation has been enacted, and many legislative initiatives and other actions that would have been detrimental to veterans and their families have also been defeated.

More recently, millions of men and women have been called to serve in the Afghanistan and Iraq wars and again the moral obligation to care for those who willingly step in harm's way is being exercised. The men and women of our Reserves and National Guard are being asked to serve in a nontraditional manner, yet they fulfill the demand made upon them without hesitation.

Yet, the struggle to protect and enhance programs and services created to rehabilitate wartime disabled veterans continues. Thus, our convention delegates, who are the leaders within their states and local organizations of the DAV, have adopted resolutions this year to bring heavy consideration to and address the needs of service-connected disabled veterans. We will shape government policy and pursue what is right for today's and tomorrow's disabled veteran. As a Nation, we must not mistake symbolism for substance when our battles are not all won.

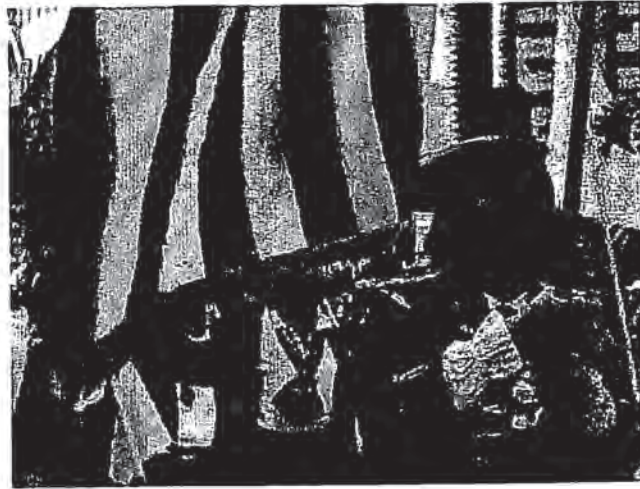
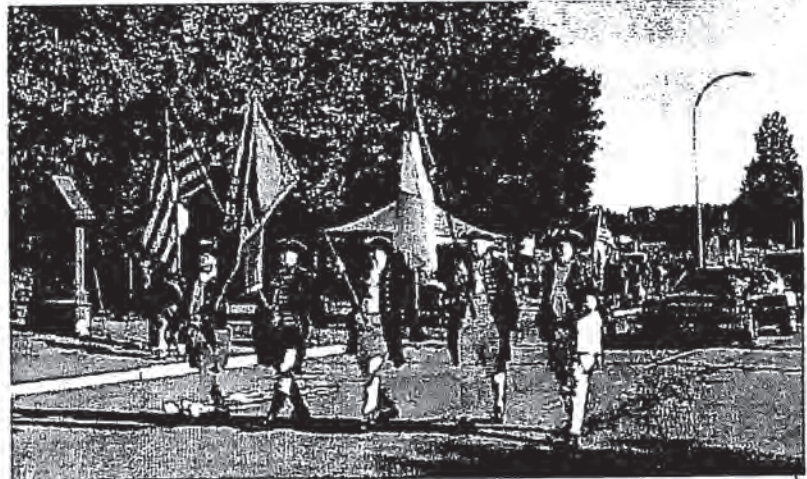
