2 3. On April 18, 2014, the Washington State Liquor Control Board ("LCB") issued
3 Monkey Grass Farms, LLC, Washington state licenses to produce and process marijuana.


4 4. On July 8, 2014, Monkey Grass Farms, LLC transacted its first sales of marijuana
5 meeting LCB regulatory standards to Washington state-licensed marijuana retail stores, and
6 continues to make such sales through the present day.

7 5. Monkey Grass Farms, LLC employs twenty-five staff.

8 6. Beginning on or about January 1, 2014, and extending to the present day, Monkey
9 Grass Farms, LLC has invested and expended significant time and financial resources to build
10 out and equip the Monkey Grass Farms, LLC facility to meet state regulatory standards; execute
11 necessary business documents; locate suppliers, vendors, and licensed retail stores; meet with
12 attorneys and accountants; attend educational seminars; and participate in and complete other
13 activities and projects related to our launch of what we hope will be a successful marijuana
14 production and processing business. A rough estimate of the funds invested and expended to
15 date is \$225,000.
