I am licensed to practice law in Washington State. Since March 10, 2014, I have 17 been employed as a Staff Attorney with Disability Rights Washington. 18 3. On October 28, 2014, I met with R.H. at Franklin County Jail. R.H. was booked 19 on October 2, 2014 in connection with a charge of Assault in the Third Degree. Attached as 20 Exhibit A is a true and accurate excerpt of the Franklin County Jail inmate roster. 21 4. Based on my attempt to interview him, R.H. appeared to have severe memory 22 issues. He could not answer my questions regarding his name, how long he had been in the jail, 23

or whether he had an attorney. R.H. also stated he could not remember the names or faces of any family members including whether family members had visited the jail.

- 5. R.H. reported constant head pain. He also reported blurry vision and told me he sees white and orange balls of light.
- 6. When I met with R.H., I observed dark brown material on R.H.'s fingers and hands. When I asked him what was on his hands, R.H. replied that it was his own feces. He proceeded to lick the feces from his fingers and hands. I also observed R.H. marking the walls with feces on his hands.
- 7. On the same day I met R.H., a court ordered him for competency evaluation. Attached as Exhibit B is a true and accurate copy of the trial court's October 28, 2014 order for a competency evaluation by Eastern State Hospital.

I declare under penalty of perjury under 28 U.S.C. § 1746, that the forgoing is true and accurate.
